

**REQUEST FOR FEE SUBSIDY
For September 2009 to August 2010**

The information contained within these documents will be retained in confidence and only reviewed by the subsidy screening team.

How to Apply:

Your daughter is welcome to attend meetings with her unit while this application is being processed. At the time of registration identify on the payment form that you will be requesting subsidy and submit the minimum payment of \$45 (either one payment of \$45 or deposit of \$25 plus one payment of \$20 payable on October 1, 2009) with your application.

Financial Support Subsidy:

The registration fee for the 2009-2010 Guiding year remains at \$125. Families are required to pay a minimum of \$45 for each girl registering. The remaining \$80 is eligible to be considered for subsidy.

Sibling Discount:

Families with three or more girls registering will automatically receive the sibling discount upon completion of the original registration materials and do not need to complete this form unless additional subsidy is requested.

Deadline for Submission:

Requests received will be processed on an ongoing basis beginning July 1, 2009.
